### Special Notice

Kindly note that applicants WITHOUT APPOINTMENTS will not be allowed entry/access to the missions services. Applicants WITH APPOINTMENTS PAST THE DUE DATE, will have to contact the mission to reschedule. ALL PAYMENTS should be done in the NAME OF THE APPLICANT, regardless of whether it is paid for on behalf of the applicant or by the applicant him/herself. Failure to comply will cause delays in the issuance of your passport application. Applicants WITHOUT APPOINTMENTS Thank you.

The application should be submitted with i) Evidence of citizenship and ii) Evidence of identity that meet the requirements under the following categories:

GUARANTORS: By their undertaking, the Gurantors are deemed to have agreed jointly and severally to pay all expenses that may be incurred by the government on the Applicant in the event of the Applicant being repatriated or dying abroad.

This application form must be submitted in person by the Applicant to any office authorised to receive such an application and should be witnessed by a person in one of the following categories to whom the applicant is personally known.

- A Commissioned Officer of the Armed Forces (Captain and above) or persons of equivalent rank in the security services.
- o A Senior Civil or Public Servant (Principal Executive Officer and above)
- o Registered Medical Practitioner
